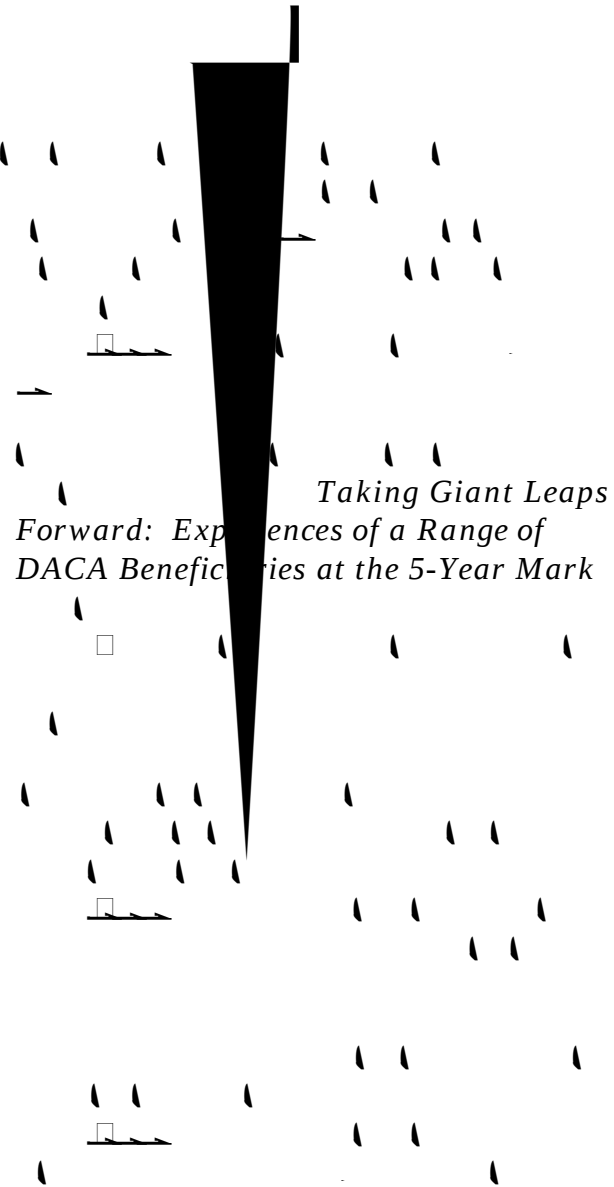

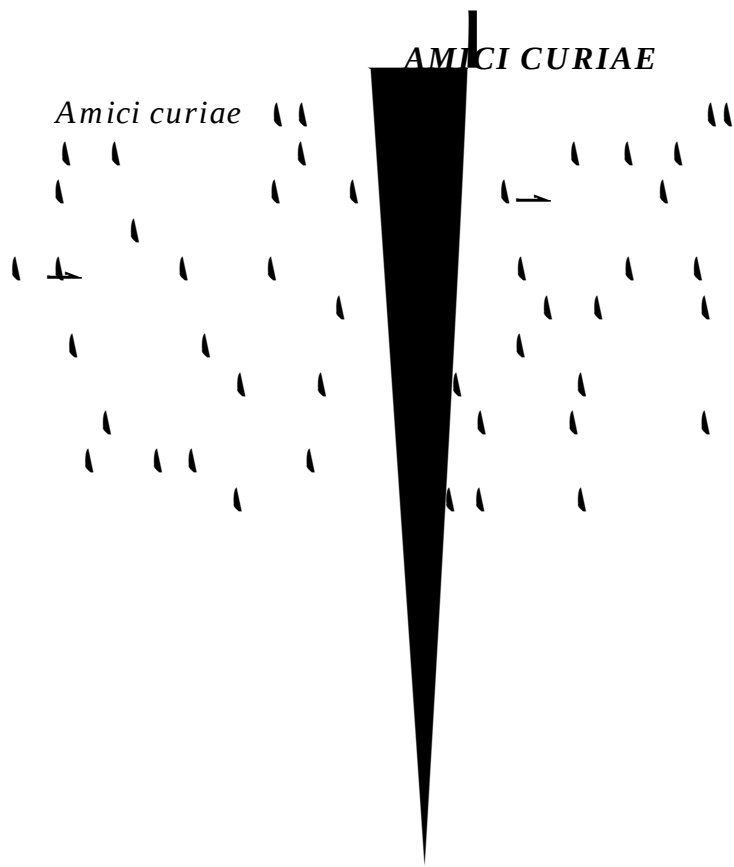

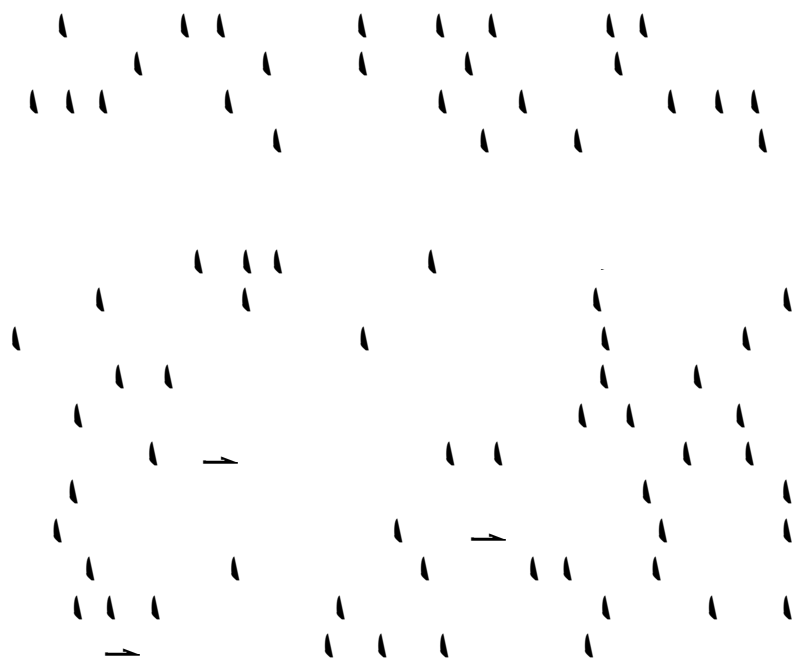


*How many people will

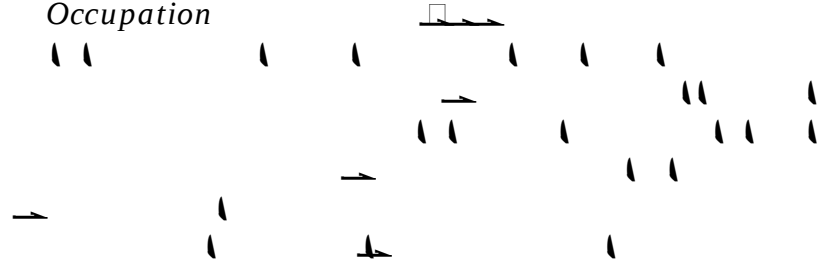
